SUBJECT: [FINAL REMINDER!] - Submission Process: Certification of Annual Voting System Security Plan Review Due Sept 6, 2024

WHY THIS IS NEEDED: Pursuant to [24.2-625.1\(D\)](#), Electoral Boards must annually review and update as necessary their locality's Voting System Security Plan (*separate from the LESS requirements*) to ensure the security and integrity of its electronic voting systems. Compliance with this requirement is certified in a letter submitted by the Electoral Board to the Department of Elections (on letterhead), dated and signed by all members of the board.

HOW THIS AFFECTS YOU: Annual certification statements/letters must be uploaded to ELECT using a specified Formsite link no later than **60 days before the November elections**, annually.

NOTE: This letter should *not include* any additional information surrounding the security posture of the locality or systems specifically. The locality should **not** upload their Voting System Security Plan as part of this process. Only submit the annual certification letter with the Electoral Board's attestation that they have reviewed/updated their locality's Voting System Security Plan for the year.

ACTION ITEMS: **By September 6, 2024**, ELECT requests submission of your locality's 2024 annual certification letter as follows:

1. Electoral Board members should certify via signed letter (on letterhead) their annual review/update of the locality's Voting System Security Plan pursuant to Va. Code [§ 24.2-625.1\(D\)](#) (**Reminder, this letter should not include the plan itself, nor any additional information surrounding the security posture of the locality or systems,**

specifically).

2. General Registrar should upload the Electoral Board's annual certification letter to Formsite, here: [REDACTED]
3. For system security, please continue to submit all LESS documents via JIRA ticket (JIRA > Security Services > LESS Compliance).
