**DATE:** January 22, 2025

**SUBJECT:** 2025 NVRA Voter Cancellation

**WHY THIS IS NEEDED:** The cancellation of inactive voters is part of a list maintenance process mandated by the National Voter Registration Act (NVRA). Under 52 USC § 20507(d)(2)(A) and the Code of Virginia § 24.2-428.2, ELECT is required to cancel inactive voters who have remained inactive for two federal general elections.

This process does not have a strict due date, but it has traditionally been performed early in the calendar year following the federal election. This year, the Department of Elections (ELECT) is planning to execute the process between Monday, January 27, 2025 and Thursday, January 30, 2025. This process will cancel the registration of voters who were placed in “inactive” status on or before August 10, 2022, did not respond to multiple notices, and have not voted in any election or updated their voter registration between August 10, 2022 and today.
